Toronto, Ontario—February 17, 2018—The national executive of The Catholic Women's League of Canada, with over 80,000 members across the country, met February 15-17<sup>th</sup> for its annual winter executive meeting. Every Canadian province and territory was represented as various committees met to discuss matters important to Catholic women and their families.

The increasing marginalization of the Catholic voice and the rights of Catholics to live their beliefs and hold their convictions was a prominent theme during the meetings. Among other matters, the national executive agreed to write a letter to the prime minister of Canada expressing members' concern about the attestation requirement of the 2018 Canada Summer Jobs Program. The attestation affects not only Catholic charities and non-profits, it affects devout Catholics, and non-Catholics with similar beliefs, who contribute to the economy by providing temporary jobs through their own independent businesses. All Catholics, regardless of their choice of vocation, should be eligible to apply and receive funding from the federal government without being asked to compromise or deny their beliefs.

Another primary focus of the weekend was a continuation of long-term strategic development. After extensive consultation with representation from within the CWL, the national executive was presented with draft strategies that support the long term vision of the League. With the blessing of the national executive, the steering committee will be making consultative visits at all diocesan conventions to affirm the direction that will be undertaken, prior to presenting a five-year strategy plan in August 2018.
