



## The Catholic Women's League of Canada Position Paper

---

### **TITLE: Matrimony and Same-sex Unions**

#### **POSITION STATEMENT**

The Catholic Women's League of Canada is committed to recognizing the bond of marriage as a matrimonial covenant between one man and one woman to the exclusion of all others and for showing respect and love for the dignity of partners in same-sex unions, their families and their children.

- The League is committed to strengthening and protecting matrimony as an institution fundamental to the growth and prosperity of civilization and calls for marriage to be defined in Canadian law as between one woman and man to the exclusion of all others.

#### **BACKGROUND**

Marriage in the Catholic church is a sacrament. The *Catechism of the Catholic Church* defines the sacrament of matrimony as, "The matrimonial covenant, by which a man and a woman establish between themselves a partnership of the whole of life, is by its nature ordered toward the good of the spouses and the procreation and education of offspring; this covenant between baptized persons has been raised by Christ the Lord to the dignity of a sacrament" (1601).

The *Catechism of the Catholic Church* and Pope Francis, in his apostolic exhortation, *Amoris Laetitia* state that every person is to be respected in their dignity and treated with respect, love and compassion and that homosexual persons must be accepted with dignity, respect, compassion, consideration and sensitivity (Francis 250; Vatican 2358).

The *Responsum of the Congregation for the Doctrine of the Faith* states that individuals who identify as homosexual may receive a blessing but that the blessing of homosexual unions cannot be considered licit as this would "constitute a certain imitation or analogue of the nuptial blessing invoked on the man and woman united in the sacrament of matrimony."

Through *The Civil Marriage Act* (formerly Bill C-38), the federal government defines civil marriage as "the lawful union of two persons to the exclusion of all others," thus extending civil marriage to conjugal couples of the same sex." The act confirms the right to freedom of religion and asserts that religious groups are free not to perform marriages that are not in accordance with their religious beliefs (Hurley).

## SUPPORTIVE ACTIONS

- Be knowledgeable and supportive of the Roman Catholic Church’s teaching on matrimony and same-sex unions.
- Advocate for and take action to strengthen and protect matrimony as an institution fundamental to the growth and prosperity of civilization.
- Advocate for the natural human rights and dignity of all persons.
- Monitor and act upon federal and provincial legislation to protect religious freedom and church teaching on marriage, including the definition of same-sex unions as civil unions.
